INTRODUCTION

The purpose of this circular is to provide you with information in respect of the Ordinary Resolutions to be proposed at the AGM for the granting to the Directors of general mandates to issue and buy back Shares and re-election of retiring Directors.

LETTER FROM THE BOARD

GENERAL MANDATES TO ISSUE AND BUY BACK SHARES

At the annual general meeting of the Company held on 18 August 2016, ordinary resolutions were passed granting the Issue Mandate and the Buy-back Mandate to the Directors. In accordance with the provisions of the Listing Rules and the terms of the Issue Mandate and the Buy-back Mandate, the Issue Mandate and the Buy-back Mandate will lapse at the conclusion of the AGM.

Resolutions numbered 5 and 6 as set out in the AGM Notice will be proposed at the AGM to grant to the Directors a general mandate:

- (a) to allot, issue and deal with Shares not exceeding:
 - (i) in the case of an allotment and issue of Shares for cash (other than an allotment and issue of Shares pursuant to a rights issue), 5% of the aggregate nominal amount of the issued share capital of the Company as at the date of the AGM; and
 - (ii) in the case of an allotment and issue of Shares other than for cash, 20% of the aggregate nominal amount of the issued share capital of the Company as at the date of the AGM (less Shares (if any) issued pursuant to the general mandate granted pursuant to sub-paragraph (i) above),

provided that, in any event, any Shares to be allotted and issued pursuant to this general mandate shall not be allotted and issued at a discount of 5% or more to the Benchmark Price of the Shares; and

- (b) to buy back Shares the aggregate amount of which does not exceed 10% of the aggregate nominal amount of the issued share capital of the Company as at the date of the AGM.

Subject to the passing of resolutions numbered 5 and 6 as set out in the AGM Notice, resolution numbered 7 will be proposed to extend the general mandate granted to the Directors pursuant to resolution numbered 5 by adding to it the aggregate nominal amount of the issued share capital bought back by the Company pursuant to the Proposed Share Buy-back Mandate.

Based on the number of Shares in issue of 335,432,520 as at the Latest Practicable Date and assuming that such issued share capital remains unchanged at the date of the AGM, the maximum number of Shares which may be issued pursuant to the general mandate granted to the Directors under resolution numbered 5 will not exceed 67,086,504 Shares, being 20% of the aggregate nominal amount of the issued share capital of the Company as at the date of the AGM.

An explanatory statement required by the Listing Rules to be sent to the Shareholders in connection with the Proposed Share Buy-back Mandate is set out in Appendix to this circular. Appendix contains all information reasonably necessary to enable the Shareholders to make an informed decision on whether to vote for or against the relevant resolution at the AGM.

RE-ELECTION OF DIRECTORS

According to bye-law 87 of the Bye-laws, Ms. Cheung Lai See, Sophie and Dr. Chan How Chun, Rita will retire by rotation at the AGM and, being eligible, offer themselves for re-election.

According to bye-law 86(2) of the Company's Bye-laws, Dr. Cheung Shu Sang, William shall hold office until the forthcoming annual general meeting and shall be eligible for re-election.

A brief biography of each of Ms. Cheung Lai See, Sophie, Dr. Chan How Chun, Rita and Dr. Cheung Shu Sang, William and other relevant particulars are set out as follows:

Ms. Cheung Lai See, Sophie, aged 54, is an Executive Director of the Company and joined the Group in 1995. She obtained a degree in Bachelor of Science from the University of London, England and a master degree in Business Management from the City University, England. She is responsible for the financial and administration functions of the Group. She has not held any directorship in other public companies during the last three years.

Ms. Cheung is a director of all subsidiaries of the Company. She is also a director of Unison Associates Limited and Allan Investment Company Limited, controlling shareholders of the Company. She has entered into a service contract with the Company for a term of 3 years subject to retirement by rotation and re-election at an annual general meeting of the Company in accordance with the Bye-laws. Ms. Cheung is entitled to a fixed basic salary and an additional discretionary bonus based on a combination of individual and corporate performance. With her executive position, Ms. Cheung is not entitled to any director's fee otherwise available to non-executive directors.

Ms. Cheung is the daughter of Mr. Cheung Lun, the Honorary Chairman; sister of Ms. Cheung Lai Chun, Maggie, the Chairman, Mr. Cheung Shu Wan, the Managing Director, Dr. Cheung Shu Sang, William, Executive Director and Mr. Cheung Shu Chun, Simon, the Director of Cost Innovation; and also the cousin of Mr. Cheung Pui, Executive Director. As at the Latest Practicable Date, according to the register maintained by the Company pursuant to section 352 of the SFO, Ms. Cheung has personal interest in 1,258,000 shares and the trustee of The Cheung Lun Family Trust (the beneficiaries of which include Ms. Cheung and other family members other than spouse) directly and indirectly has interest in 149,049,960 shares of the Company. Details of her interests are provided in the "Directors' and Chief Executives' Interests and Short Positions in Shares, Underlying Shares and Debentures" section in the 2016/2017 Annual Report of the Company.

Save as disclosed above, there are no other matters relating to her re-election that need to be brought to the attention of the Shareholders and there is no information which is required to be disclosed pursuant to any of the requirements of rules 13.51(2)(h) to 13.51(2)(v) of the Listing Rules.

Dr. Chan How Chun Rita, aged 62, is the Independent Non-Executive Director of the Company and joined the Group on 28 September 2004. She has extensive experience in accounting, finance and management. She holds a Bachelor degree in Commerce and a Master degree in Business Administration from the University of Windsor in Canada and a PhD degree in Management from the Hong Kong Baptist University.

Dr. Chan does not have any relationship with any other Directors, senior management of the Company, substantial shareholders (as defined in the Listing Rules) or controlling shareholders (as defined in the Listing Rules).

There is no service agreement between the Company and Dr. Chan How Chun, Rita as acting as Independent Non-Executive Director but Dr. Chan is entitled to receive an annual directors' fee of HK\$120,000 for the financial year ended 31 March 2017 based on the Group's remuneration policies, which is subject to the approval of the Board, and is determined and reviewed by the Board each year. Dr. Chan forfeited her annual director's fee since 2006. Dr. Chan has not held any directorship in other public companies during the last three years.

As at the Latest Practicable Date, Dr. Chan does not have, and is not deemed to have, any interests or short positions in any shares, underlying shares or debentures of the Company and/or its associated corporations (with the meaning of Part XV of the SFO).

Pursuant to paragraph A.4.3 of the Corporate Governance Code set out in Appendix 14 to the Listing Rules, any further appointment of an independent non-executive director in excess of nine years should be subject to a separate resolution to be approved by shareholders. Dr. Chan was appointed as an independent non-executive director of the Company in 2004 and has served on the Board for more than nine years. In accordance with Bye-law 87 of the Bye-laws, Dr. Chan should retire at the AGM. Nevertheless, the Board recommends the Shareholders to vote in favour of the resolution to re-elect Dr. Chan as an independent non-executive director of the Company for a further term of three years. Dr. Chan has never held any executive or management position in the Group nor has she throughout such period been under the employment of any member of the Group. There is no evidence that the independence of Dr. Chan, especially in terms of exercising independent judgment and objective challenges to the management, has been or will be in any way compromised or affected by her length of service to the Company. The Board is confident that Dr. Chan will continue to make valuable contribution to the Company by providing her balanced and objective views to the Board. Dr. Chan has also provided an annual confirmation of independence pursuant to Rule 3.13 of the Listing Rules. The Board therefore comes to the view that Dr. Chan should be re-elected for a further term at the AGM.

Save as disclosed above, there are no other matters relating to her re-election that need to be brought to the attention of the Shareholders and there is no information which is required to be disclosed pursuant to any of the requirements of rules 13.51(2)(h) to 13.51(2)(v) of the Listing Rules.

Dr. Cheung Shu Sang, William, aged 52, is the Executive Director and joined the Group in 1994. He holds a BSc degree in Computing Science and a MSc degree in Management Science, both at Imperial College London. He also holds a PhD degree in Automation at the University of Bristol, and is a member of The Hong Kong Institution of Engineers. He is in charge of engineering, research and development functions, and also management of intellectual property/patent application. Dr. Cheung has not held any directorship in other public companies during the last three years.

Dr. Cheung is a director of Allan Toys Manufacturing Limited and Total Profits Limited, all being subsidiaries of the Company. He is also a director of Allan Investment Co. Ltd., a Controlling Shareholder of the Company (as defined in the Listing Rules). Dr. Cheung has entered into a service contract with the Company for a term of 3 years subject to retirement by rotation and re-election at an annual general meeting of the Company in accordance with the Bye-laws. Dr. Cheung is entitled to a fixed basic salary and an additional discretionary bonus based on a combination of individual and corporate performance. With his executive position, Dr. Cheung is not entitled to any director's fee otherwise available to non-executive directors.

Dr. Cheung is the son of Mr. Cheung Lun, the Honorary Chairman of the Group; brother of Ms. Cheung Lai Chun, Maggie, the Chairman, Mr. Cheung Shu Wan, the Managing Director, Ms. Cheung Lai See, Sophie, an Executive Director and Mr. Cheung Shu Chun, Simon, the Director of Cost Innovation; and also the cousin of Mr. Cheung Pui, an Executive Director of the Group. As at the Latest Practicable Date, according to the register maintained by the Company pursuant to section 352 of the SFO, Dr. Cheung has personal interest in 900,000 shares and the trustee of The Cheung Lun Family Trust (the beneficiaries of which include Dr. Cheung and other family members other than spouse) directly and indirectly has interest in 149,049,960 shares. Details of his interests are provided in the "Directors' and Chief Executives' Interests and Short Positions in Shares, Underlying Shares and Debentures" section in the 2016/2017 Annual Report of the Company.

Saved as disclosed above, there is no other matters relating to his re-election that need to be brought to the attention of the Shareholders and there is no information which is required to be disclosed pursuant to any of the requirements of rules 13.51(2)(h) to 13.51(2)(v) of the Listing Rules.

VOTING BY POLL

Pursuant to the Listing Rules, any vote of the Shareholders at a general meeting must be taken by poll except where the chairman, in good faith, decides to allow a resolution which relates purely to a procedural or administrative matter to be voted on by a show of hands. Therefore, the chairman of the AGM will demand a poll for all the resolutions set out in the AGM Notice. After the conclusion of the AGM, the results of the poll will be published on the websites of the Stock Exchange (www.hkexnews.hk) and of the Company (www.allan.com.hk).

RESPONSIBILITY STATEMENT

This circular, for which the Directors collectively and individually accept full responsibility, includes particulars given in compliance with the Listing Rules for the purpose of giving information with regard to the Company. The Directors, having made all reasonable enquiries, confirm that to the best of their knowledge and belief the information contained in this circular is accurate and complete in all material respects and not misleading or deceptive, and there are no other matters the omission of which would make any statement herein or this circular misleading.

RECOMMENDATION

The Board considers that the proposals relating to the granting of general mandates to issue and buy back Shares and re-election of Directors are in the best interests of the Company and its shareholders as a whole and accordingly recommends you to vote in favour of the relevant resolutions to be proposed at the AGM.

This Appendix contains the particulars that are required by the Listing Rules to be included in an explanatory statement to enable the Shareholders to make an informed view on whether to vote for or against the resolution to be proposed at the AGM in relation to the Proposed Share Buy-back Mandate.

LISTING RULES FOR BUY-BACK OF SHARES

The relevant sections of the Listing Rules which permit companies with primary listing on the Stock Exchange to buy back their shares on the Stock Exchange subject to certain restrictions are summarised below:

SOURCE OF FUNDS

Buy-back must be funded out of funds legally available for the purpose and in accordance with the company's constitutional documents and the laws of the jurisdiction in which the company was incorporated or otherwise established.

SHARE CAPITAL

As at the Latest Practicable Date, the number of Shares in issue was 335,432,520. Subject to the passing of the resolution granting the Proposed Share Buy-back Mandate and on the basis that no further Shares are issued or bought back before the AGM, the Company will be allowed to buy back a maximum of 33,543,252 Shares during the period ending on the earlier of the conclusion of the next annual general meeting of the Company or the date by which the next annual general meeting of the Company is required to be held by law or the date upon which such authority is revoked or varied by a resolution of the Shareholders in general meeting.

REASONS FOR BUY-BACK

The Directors believe that it is in the best interest of the Company and the Shareholders to seek a general authority from the Shareholders to enable the Company to buy back its Shares on the Stock Exchange. Such buy back may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net asset value of the Company and earnings per Share and will only be made when the Directors believe that such a repurchase will benefit the Company and the Shareholders.

The Directors have no present intention to buy back any Shares and they would only exercise the power to buy back in circumstances where they consider that the buy back would be in the best interests of the Company. The Directors consider that if the general mandate to buy back Shares were to be exercised in full at the currently prevailing market value, it would have a material adverse impact on the working capital position and gearing position of the Company, as compared with the positions disclosed in the audited consolidated financial statements of the Company for the year ended 31 March 2017, being the date to which the latest published audited financial statements of the Company were made up. The Directors do not propose to exercise the Proposed Share Buy-back Mandate to such extent as would, in the circumstances, have a material adverse effect on the working capital requirements or the gearing levels of the Company which in the opinion of the Directors are from time to time appropriate for the Company.

GENERAL

To the best of their knowledge, having made all reasonable enquiries, none of the Directors nor any of their associates currently intend to sell any Shares to the Company or its subsidiaries in the event that the Proposed Share Buy-back Mandate is approved.

The Directors have undertaken to the Stock Exchange that, so far as the same may be applicable, they will exercise the Proposed Share Buy-back Mandate in accordance with the Listing Rules and the applicable laws of Bermuda.

No connected person has notified the Company that he has a present intention to sell any Shares to the Company or has undertaken not to do so in the event that the Proposed Share Buy-back Mandate is approved.

If as a result of a buy back of Shares, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition for the purposes of the Takeovers Code. Accordingly, a Shareholder, or a group of Shareholders acting in concert, depending on the level of increase of the Shareholders' interest, could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with rule 26 of the Takeovers Code.

As at the Latest Practicable Date, the trustee of The Cheung Lun Family Trust (the beneficiaries of which include Ms. Cheung Lai Chun, Maggie, Mr. Cheung Shu Wan, Ms. Cheung Lai See, Sophie, Dr. Cheung Shu Sang, William and other family members other than spouse) and other parties associated with the Cheung family hold directly or indirectly 60.36% of the issued share capital of the Company.

In the event that the Directors shall exercise the Proposed Share Buy-back Mandate in full and assuming there is no change in the issued share capital of the Company as at the date of passing the relevant resolution granting the Proposed Share Buy-back Mandate, the interest of the trustee of The Cheung Lun Family Trust and other parties associated with the Cheung family would be increased to approximately 67.07%. To the best knowledge of the Directors, these situations would not give rise to any consequences under the Takeovers Code and at least 25% of the issued share capital of the Company would still remain in public hands.

The Company has not bought back any Shares on the Stock Exchange in the six months preceding the date of this circular.

- (b) the approval given in paragraph (a) of this resolution shall be in addition to any other authorisation given to the Directors and shall authorise the Directors during the Relevant Period to make or grant offers, agreements and options which might require the exercise of such powers after the end of the Relevant Period;
